Referral Workflow Action Forms

1. Appointment Booked WF Action Form

Description:	Add "Virtual" Option to the Appointment Type dropdown menu in the Appointment Booked WF Action Form
Details:	<p>The Appointment Type field in the Appointment Booked WF Action Form has been updated to include a third option. The Appointment Type field now displays three options in the following order:</p> <ol style="list-style-type: none"> 1. Virtual (new) 2. Screening 3. Consult

2. Complete (T5) WF Action Form

Description:	Update the Complete (T5) WF Action form - appointment date to auto-populate and more options added to the Outcome field
Details:	<ol style="list-style-type: none"> 1. The value in the Accepted Date (T3) Workflow Action Form automatically displays in the Complete (T5) form when user accesses the Complete (T5) Workflow Action Form. 2. Value in the Date Appointment Attended (T5) field is defaulted to the date set (if there is one) in the Appointment Booked Workflow Action Form. 3. Appointment Type field is added to the Complete (T5) Workflow Action Form. 4. Options on the Outcome menu increased to 8 with 2 new additions: <ol style="list-style-type: none"> a. Procedure completed at appointment b. Pre-screening completed; information not provided by service 5. Listed options on the Outcome menu display in the following order: <ol style="list-style-type: none"> a. Procedure completed at appointment b. Patient discharged from our care, as per consult letter c. We will continue ongoing patient care d. Booking the patient for procedure e. Pre-screening completed and patient will be booked to see specialist f. Pre-screening completed; patient discharged as per consult letter g. Pre-screening completed; information not provided by service h. Information Not Provided by Service

3. Received Date (T2) WF Action Form

Description:	Remove time stamp from the Update Received Date (T2) WF Action form
Details:	Time stamp in the Received Date (T2) WF Action form is disabled.

Create Referrals (CR) Standard Form

1. Patient's Current Status in Create Referrals Standard Form

Description:	Revert Patient's Current Status Field in the Create Referrals (CR) Standard Form to pre-V5 Configuration
Details:	<p>The process in the "Patient's current status" field within the Create Referrals (CR) Standard Form is reverted to the procedure in the previous version of eReferral when the user could use the radio button options only and add text as an optional step to describe a patient's current status. Updated process includes a radio button option menu, with the following options, and it sets the comment box to optional:</p> <ol style="list-style-type: none"> 1. Stable 2. Condition worsening 3. Unknown - status not provided

Bug Fix

1. Printing Patient's pertinent history

Description:	Patient's pertinent history appears wonky and cut out during printing
Details:	A bug causing the "Patient's pertinent history" page to appear wonky and cut out during printing is fixed.
